# Hewlett-Packard GC resigns after probe on boardroom leaks

Ann Baskins, General Counsel for Hewlett-Packard, has resigned after being drawn into an investigation on boardroom leaks to the media. Baskins is the fourth employee of the company who has been called in on the probe. Patricia Dunn, the company chairwoman, and two employees had earlier resigned following the start of the investigations. Baskins joined Hewlett-Packard after graduating from law school 24 years ago and served as General Counsel from 2000 until her resignation. The move is slated to empower Mark Hurd, Chief Executive Officer for Hewlett-Packard, who said the resignations were in the best interests of the company.
